ARTICLES OF INCORPORATION

OF

SOUTH FLORIDA AFFORDABLE HOME INVESTMENT, INC.

The undersigned does hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

ARTICLE ONE

The name of the corporation is: **SOUTH FLORIDA AFFORDABLE HOME INVESTMENT**, **INC**.

ARTICLE TWO
