

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

**ARTICLE I.**

The name of this corporation is **GRAVES QUALITY SERVICE & REPAIR, INC.**

**ARTICLE II.**

The main location where the company shall conduct its business is 3454 Dornbush Road, Callahan, Florida 32011.

The duration of the corporation shall be perpetual.
