Articles of Incorporation Of RB Institute, Inc.



ARTICAL I - NAME

The name of this corporation shall be RB Institute, Inc.

ARTICLE II - DURATION

The corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE III - PURPOSE
