The undersigned subscriber, a natural person competent to contract, hereby subscribes to and adopts these Articles of Incorporation for the purpose of organizing a corporation under the Florida Business Corporation Act.

ARTICLE I CORPORATE NAME

The name of the corporation shall be:

ARTICLE II PRINCIPAL OFFICE AND MAILING ADDRESS

The maximum number of shares of stock that this corporation is authorized to issue and have outstanding at any one time shall be 5,000 shares of common stock, each with a par value of one cent (\$.01) per share. The corporation shall issue to John Calvin Clemons one hundred (100) shares of said common stock in consideration of the sum of one dollar (\$1.00), and said shares shall represent 100% ownership of this corporation. A Statement in Lieu of Stock Certificate shall evidence his ownership of said one hundred (100) shares.
