ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF

EUROPEAN SPECIALTY LATIN AMERICA, INC. A Florida corporation

Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida profit corporation adopts the following articles of amendment to its articles of incorporation:

FIRST: Amendment adopted:

ARTICLE I

CORPORATE NAME

The name of the corporation shall be changed from EUROPEAN SPECIALTY LATIN AMERICA, INC. to ESG RE LATIN AMERICA, INC.

SECOND: The date of the amendment's adoption is December _______, 2003.

THIRD: The Secretary shall cancel all previously issued certificates of stock and issue, in exchange, to each shareholder, certificates of stock under the new name of the Corporation, for the same class and for the same number of shares as the certificates being cancelled.

FOURTH: Adoption of Amendment:
