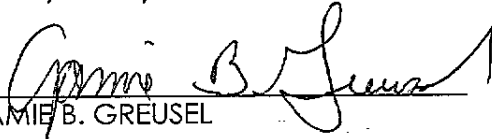

X. AMENDMENTS

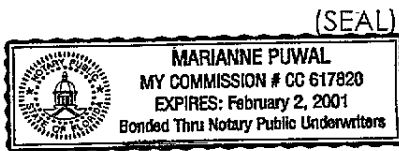
