ARTICLES OF INCORPORATION
OF
ALEXANDER & ASSOCIATES ELECTRONIC SERVICES, INC.

ARTICLE I.

The name of this corporation is: ALEXANDER & ASSOCIATES ELECTRONIC SERVICES, INC., and its address is Suite 310, 3545-1, St. John's Bluff, Jacksonville, Florida 32224.

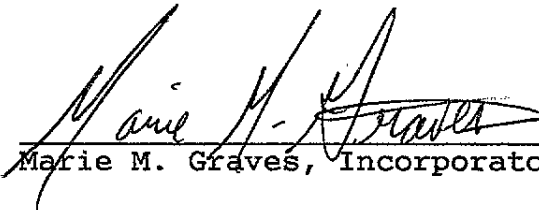
