

ARTICLE I. CORPORATE NAME.

The name of this corporation is **TEXTURED CONCRETE DESIGNS, INC.**

ARTICLE II. PRINCIPAL OFFICE.

ARTICLE III. CAPITAL STOCK.

The number of shares of stock that this corporation is authorized to have
outstanding at any one time is 1000, \$1.00 par value.


