- 1. Thomas G. Peters is the President of PARK AVENUE T.L.C., INC., a Florida corporation, (hereinafter "Corporation").
- 2. That the Corporation was administratively dissolved by the Florida Department of State on September 19, 2003.
- 3. That the Corporation failed to file its 2003, 2004, and 2005 Annual Reports or pay the 2003, 2004, 2006 and 2005 Annual Report filing fees within the time prescribed by Florida Statutes Chapter 607 because:

- 6. No further ground or grounds exist for the administrative dissolution of the Corporation.
