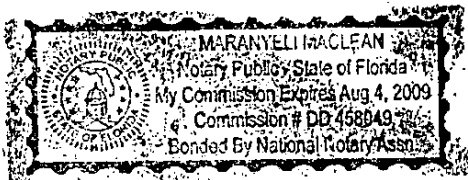
1. Thomas G. Peters is the President of PARK AVENUE T.L.C., INC., a Florida corporation, (hereinafter "Corporation").
