## ARTICLES OF INCORPORATION OF VACWELL PROPERTY MANAGEMENT INC.

The undersigned, acting as Incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of incorporation for such corporation:

ARTICLE I - NAME. The name of this corporation is VACWELL PROPERTY MANAGEMENT INC.
