The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, Chapter 607, Florida Statutes, hereby adopts the following Articles of Incorporation.

ARTICLE I: NAME

*The name of the corporation shall be **ENTERPRISE SPORT FISHING CHARTERS, INC.***

ARTICLE II: PRINCIPAL OFFICE

The name and address of the initial director of the corporation is Thomas R. Kamp, P.O. Box 1774 Land-O-Lakes, Florida 34639.

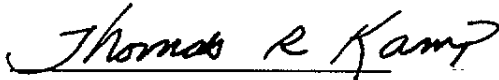
ARTICLE VII: PURPOSE

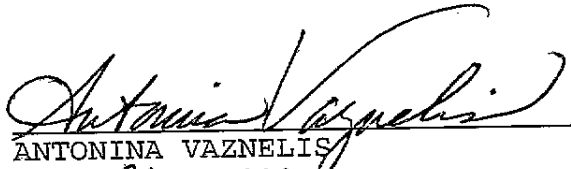
**CERTIFICATE OF DESIGNATION
