

ARTICLE ONE

The name of the corporation is **PETER R. THEN, DMD, DR.MED.DENT., PA.** The principal address of the corporation is: **480 Jefferson Drive, #203, Deerfield Beach, Florida 33442.**

The Board of Directors is empowered to make, alter or repeal the Bylaws of the corporation without restriction of their powers conferred by statute.


