OF

ARTICLE I - NAME

The name of this corporation is: **TRADE NOW, INC.**

ARTICLE II - DURATION

This corporation shall exist perpetually.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV - CAPITAL STOCK

Members of the Board of directors may participate in meeting of the Board of Directors by mean of conference telephone as provided by law.


ARTICLE XII - INDEMNIFICATION



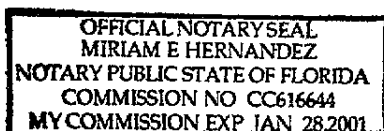
