ARTICLE I

NAME AND ADDRESS

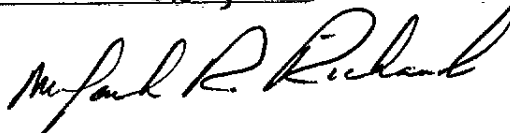

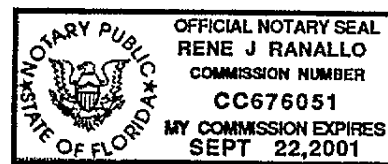
