We the undersigned, hereby associate ourselves together for the purpose of becoming a corporation under the laws of the State of Florida providing for the formation of a corporation for profit, with the powers, rights privileges and immunities hereinafter mentiones, and we hereby make, subscribe and acknowledge and file tiones, and we hereby make, subscribe and acknowledge and file with the Secretary of State of Florida this Certificate, set forth:

ARTICLE I

The name of this corporation (which is hereinafter called the "Corporation" is: AMERICAN TOP FASHION'S, INC

ARTICLE II

The general nature of the business and de objects and purposes to be transacted and carried on are to do any and all things allowed and permitted to be done by corporations under the Statutes of the State of Florida, and to do any all of the things hereinafter mentioned as fully and to the same extent as natural persons might or could do, to-witt: IMPORT & EXPORT


