The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be MENADA, INC.

The principal place of business of this corporation shall be at 7913 N.W. 2nd Street, Miami, Florida, 33126.

ARTICLE II. NATURE OF BUSINESS




