

Atlas Med Tech Inc.

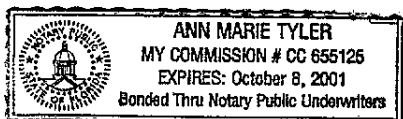
