ARTICLES OF INCORPORATION
OF
EQUITYGRAPHIX, INC.

The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation under the laws of the State of Florida.

ARTICLE I NAME OF CORPORATION

The name of the corporation shall be: EQUITYGRAPHIX, INC. Its business shall be carried on in the State of Florida, in the United States of America, and elsewhere, as may be authorized by its Board of Directors.

ARTICLE II GENERAL NATURE OF BUSINESS TO BE TRANSACTED

The general nature of the business to be transacted by the corporation shall be that provided below:

- To sue and be sued, complain, and defend in its corporate name; (a)
- To have a corporate seal which may be altered at will and to use it or a facsimile of it, by impressing or affixing it or in any (b) other manner reproducing it;
- To purchase, receive, lease, or otherwise acquire, own, hold, improve, use, and otherwise deal with real or personal property (c) or any legal or equitable interest in property wherever located;
- To sell, convey, mortgage, pledge, create a security interest in, lease, exchange, and otherwise dispose of all or any part of its (d) property;
- To lend money to, and use its credit to assist, its officers and employees in accordance with Florida Statute 607.0833; (e)
- To purchase, receive, subscribe for, or otherwise acquire, own, hold, vote, use, sell, mortgage, lend, pledge, or otherwise (f) dispose of, and deal in and with shares or other interests in, or obligations of, any other entity;
- To make contracts and guarantees, incur liabilities, borrow money, issue its notes, bonds, and other obligations (which may be (g) convertible into or include the option to purchase other securities of the corporation), and secure any of its obligations by mortgage or pledge of any of its property, franchises, and income and make contracts of guaranty and suretyship which are necessary or convenient to the conduct, promotion, or attainment of the business of a corporation the majority of the outstanding stock of which is owned, directly or indirectly, by the contracting corporation, a corporation which owns, directly or indirectly, a majority of the outstanding stock of the contracting corporation, or a corporation the majority of the outstanding stock of which is owned, directly or indirectly, by a corporation which owns, directly or indirectly, the majority of the outstanding stock of the contracting corporation, which contracts of guaranty and suretyship shall be deemed to be necessary or convenient to the conduct, promotion, or attainment of the business of the contracting organization, and make other contracts of guaranty and suretyship which are necessary or convenient to the conduct, promotion, or attainment of the business of the contracting corporation;
- To lend money, invest and reinvest funds, and receive and hold real and personal property as security for repayment; (h)
- To conduct its business, locate offices, and exercise the powers granted by this act within or without this state; (I)
- To elect directors and appoint officers, employees, and agents of the corporation and define their duties, fix their (j) compensation, and lend them money and credit;
- To make and amend bylaws, not inconsistent with its articles of incorporation or with the laws of this state, for managing the (k) business and regulating the affairs of the corporation;
- To make donations for the public welfare or for charitable, scientific, or educational purposes; (1)

- (m) To transact any lawful business that will aid governmental policy;
- (n) To make payments or donations or do any other act not inconsistent with law that furthers the business and affairs of the corporation;
- (o) To pay pensions and establish pension plans, pension trusts, profit sharing plans, share bonus plans, share option plans, and benefit or incentive plans for any or all of its current or former directors, officers, employees, and agents and for any or all of the current or former directors, officers, employees, and agents of its subsidiaries;
- (p) To provide insurance for its benefit on the life of any of its directors, officers, or employees, or on the life of any shareholder for the purpose of acquiring at his death shares of its stock owned by the shareholder or by the spouse or children of the shareholder.
- (q) To be a promoter, incorporator, partner, member, associate, or manager of any corporation, partnership, joint venture, trust, or other entity; and
- (r) To engage in the business of Internet site design, development, hosting, or remarketing, and such other lawful businesses as may from time to time be determined by the Board of Directors.

The foregoing paragraphs shall be construed as enumerating both the objects and purposes of the Corporation; however, it is hereby expressly provided that the foregoing enumeration of specific objects and purposes shall not be held to limit or restrict in any manner the objects or purposes of the Corporation otherwise permitted by law.

ARTICLE III TERM OF EXISTENCE

The Corporation is to exist perpetually unless sooner dissolved according to law.

ARTICLE IV CAPITAL STOCK

The maximum number of shares that the corporation is authorized to have outstanding at any time shall be one thousand (1,000) shares of common stock at a par value of one cent (\$0.01) per share.
