We, the undersigned, natural persons of the age of twenty-one (21) years or more, acting as incorporators of a corporation pursuant to Chapter 607/621 F.S., adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is:

SECOND: The period of duration is perpetual.

THIRD: The purposes for which the corporation is organized are:
