**ARTICLES OF INCORPORATION  
OF

I, the undersigned, do hereby execute, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

**ARTICLE I**

The name of this corporation shall be: TRANSFLORIDA COMMUNICATIONS, INC. The address of the principal office of this corporation is 21801 S.W. 167<sup>th</sup> Avenue, Goulds, Florida 33170 and the mailing address shall be the same.

**ARTICLE II**

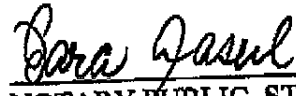
