The undersigned, being the sole incorporator of corporation, hereby submit following Articles of Amendment to its Articles of Incorporation, pursuant to the provisions of the Florida Business Corporation Act:

- The name of the corporation is: The Haskell Juvenile Facilities Finance 1. Company.
- 2. Article III of the corporation's Articles of Incorporation is hereby amended in its entirety to read as follows:

Article III. CORPORATE PURPOSE.
