OF

**ARTICLE I
NAME & PLACE OF BUSINESS**

The name of the Corporation is SIDI CORPORATION. The principal place of business and mailing address of the corporation shall be as follows: 782 NW Lejeune Road, Suite 434, Miami, Florida 33126.

**ARTICLE II
TERM OF CORPORATE EXISTENCE**

The Corporation shall exist perpetually unless dissolved according to law and such existence shall commence at the time of the filing of these Articles of Incorporation by the Department of State.

**ARTICLE III
PERMITTED ACTIVITY**

AUTHORIZED SHARES**
