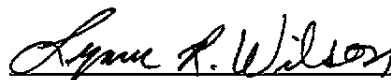

ARTICLES OF DISSOLUTION
OF
PERSONAL MINI STORAGE EAST 50, INC.

THE UNDERSIGNED, as sole Incorporator of PERSONAL MINI STORAGE EAST 50, INC., a Florida corporation (the "Corporation"), in accordance with Section 607.1401, Florida Statutes, hereby adopts the following Articles of Dissolution for the Corporation.

1. Name. The name of the Corporation is "Personal Mini Storage East 50, Inc."
2. Date of Incorporation. The Articles of Incorporation for the Corporation were filed on July 15, 1998, effective July 13, 1998, and assigned document number P98000062553.
3. Authorization to Dissolve. Dissolution of the Corporation was authorized by written consent of all of the Corporation's directors on September 28, 1998, prior to the issuance of any shares of stock.
4. Statement Concerning Debt. No debt of the Corporation remains unpaid.
