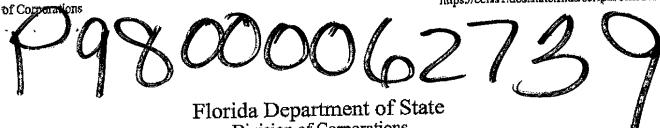

## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF COUNTRY CLUB VILLAS, INC.
