## ARTICLES OF INCORPORATION

### OF WATER HOLE, INC.

#### ARTICLE ONE

The name of this corporation is Water Hole, Inc. and the mailing address of the corporation shall be 16071 Pinto Drive, North Fort Myers, FL 33903.

#### ARTICLE TWO

The date of the commencement of corporate existence of the corporation shall be the date these Articles are filed with the Secretary of State.

#### ARTICLE THREE

The duration of the corporation is perpetual.

#### ARTICLE FOUR

The general purposes for which the corporation is organized are:

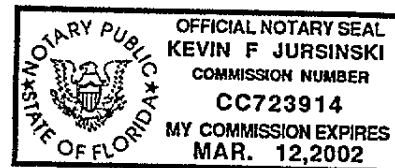

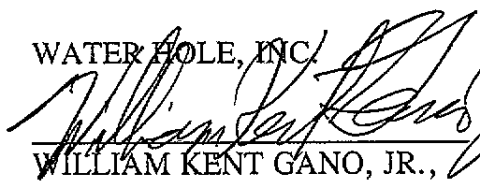
