ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME

The name of this Corporation is KING TILE RESTORATION, INC.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing immediately.

ARTICLE III - PURPOSE
