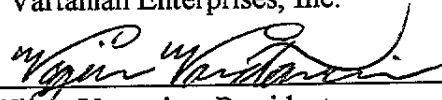

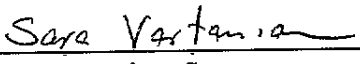

ARTICLE I
NAME

The name of the corporation is PRECISION DENTAL ARTS, INC.

ARTICLE II
DURATION

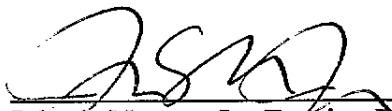
