Article I - Name

The name of this corporation is Famida Jiwa, D.C., PA.

Article II - Business and Activities

This corporation may, and is organized and authorized to, engage in any activity or business permitted under the laws of the United States and the State of Florida. Accordingly, this corporation/professional association will sell chiropractic services to the public.

Article III - Capital Stock

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 1,000 shares of common stock having a par value of \$1.00 per share, with the consideration to be paid for each share to be in money, property or services, as may be fixed by the Board of Directors.

Article IV - Term of Existence

This corporation shall have a perpetual existence.

Article V - Initial Registered Office and Agent
