


COMES NOW BEFORE ME, the undersigned authority, NORMAN G. BECKER, who being duly cautioned and sworn, deposes and says:



ARTICLES OF INCORPORATION

ARTICLE I

The name of this corporation shall be:

TOUR OF CHAMPIONS, INC.

ARTICLE II

The principal office of this corporation shall be Suite 7, 180 South Knowles Avenue, Winter Park, Florida 32789, but this corporation may establish such other offices and branch offices within or without the State of Florida as may be necessary or as may be determined by the board of directors.

ARTICLE III

The amount of capital stock authorized by this corporation shall be 100,000 shares with a par value of \$.001 per share.

ARTICLE IV

The corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.

This corporation shall be managed by a board of directors no less than 1 nor more than 9 who need not be stockholders of the corporation. 
ratifies such contract or transaction or because his or their votes are counted for such purpose, if:




