98 JUL 15 Properties of the Con The undersigned, for the purpose of forming a corporation under the law State of Florida, hereby adopts the following Articles of Incorporation.

ARTICLE I

The name of this corporation is C.K.B.K., INC. with its principal office located at 2545 South Atlantic Avenue, Daytona Beach, Florida, 32118.

ARTICLE !

This corporation shall have perpetual existence.

ARTICLE III

The general nature of the business to be transacted by this corporation is as follows:

- (a). To transact any and all lawful business for which corporations may be incorporated under the laws of the State of Florida.
- (b). To deal in the business of purchasing mortgages, investing and managing real estate.
- (c). To have a corporate seal, which may be altered at pleasure, and to use the same by causing it, or a facsimile thereof, to be impressed, affixed, or in any manner reproduced.
