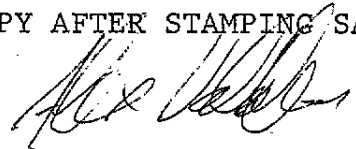

1. THE NAME OF THE CORPORATION IS UNITED MARKETING CENTER, INC.
2. THE GENERAL NATURE OF THE BUSINESS OR BUSINESSES TO BE TRANSACTED BY SAID CORPORATION IS AS FOLLOWS:  
TO ENGAGE IN ALL ASPECTS OF MARKETING.  
TO CARRY ON ANY OTHER LAWFUL BUSINESS, WHATSOEVER, INCLUDING, BUT NOT LIMITED TO, THE PROVIDING OF SERVICES, WHICH MAY SEEM TO THE CORPORATION CAPABLE OF BEING CARRIED ON FOR PROFIT OR CALCULATED DIRECTLY OR INDIRECTLY TO PROMOTE THE INTEREST OF THE CORPORATION OR TO ENHANCE THE VALUE OF ITS PROPERTIES; AND TO HAVE, ENJOY AND EXERCISE ALL THE RIGHTS, POWERS AND PRIVILEGES WHICH ARE NOW OR WHICH MAY HEREAFTER BE CONFERRED UPON CORPORATIONS ORGANIZED UNDER THE LAWS OF THE STATE OF FLORIDA.

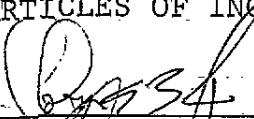
