

**ARTICLES OF INCORPORATION**

**OF**

The undersigned incorporator, for the purpose of forming a corporation in accordance with the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

**ARTICLE I. NAME**

The name of this corporation shall be NOCO VENDING, INC.

**ARTICLE II. PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be: P.O. Box 1612, Largo, FL 33779-1612.

**ARTICLE III. PURPOSE**

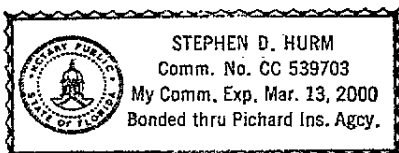


