ARTICLE I

NAME

The name of this Corporation is JIK MANAGEMENT SERVICES COMPANY

ARTICLE II

NATURE OF BUSINESS

This Corporation is being formed for the following purposes:

To conduct any and all business activities permitted by the laws of the State of Florida.
