# ARTICLES OF INCORPORATION OF A CLEAN BEGINNING, INC.

The undersigned subscriber to these Articles of Incorporation, Robert Gross, being a natural person competent to contract, hereby acknowledges and files these ARTICLES OF INCORPORATION in the Office of the Secretary of State of the State of Florida in order to form a Corporation for profit under the laws of the State of Florida.

#### ARTICLE I

#### **CORPORATE NAME**

The name of this Corporation is A CLEAN BEGINNING, INC. The principal office and mailing address of the corporation is 6700 Friendship Lane, Naples, Florida 34120.

#### ARTICLE II

#### <u>DURATION</u>

The Corporation shall have perpetual existence, commencing upon the filing of these articles with the Florida Secretary of State.

# PURPOSE PURPOSE The Corporation is organized for the purpose of transacting any or all lawful brisiness. ARTICLE IV

# CAPITAL STOCK

The Corporation is authorized to issue 1000 shares of \$1.00 par value stock, which shall be designated "common shares." The stock of the Corporation is intended to qualify under the requirements of Section 1244 of the Internal Revenue Code and all regulations issued thereunder.
