ARTICLES OF INCORPORATION OF

DOUBLE STAR MOTIVE, INC.

ARTICLE I - NAME

The name of this corporation is: DOUBLE STAR MOTIVE, INC., with the principal place of business located at: 7501 E. TREASURE DR. SUITE 9P, NORTH BAY VILLAGE, FL. 33141.

The corporation shall indemnify any officer or director, or any former officers or directors to the full extent permitted by law.


ARTICLE IX - MANAGEMENT OF CORPORATION BY SHAREHOLDERS
