# ARTICLES OF INCORPORATION OF OPPORTUNITY SYSTEMS 21, INC.

The undersigned subscriber to these Articles of Incorporation, Patricia Fitzpatrick, M 2.3 being a natural person competent to contract, hereby acknowledges and files these ARTICLES OF INCORPORATION in the Office of the Secretary of State of the State of Florida in order to form a Corporation for profit under the laws of the State of Florida.

# ARTICLE I

# **CORPORATE NAME**

The name of this Corporation is Opportunity Systems 21, Inc. The principal office and mailing address of the corporation is 203 Monterey Drive, Naples, Florida 34119.

# ARTICLE II

# **DURATION**

The Corporation shall have perpetual existence, commencing upon the filing of these articles with the Florida Secretary of State.

# ARTICLE III

#### **PURPOSE**
