# ARTICLES OF INCORPORATION OF SURPODE & ASSOCIATES, INC.

The undersigned, acting as Incorporator, signs the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida.

## **ARTICLE I**

The name of the corporation shall be:
