
ARTICLE VIII

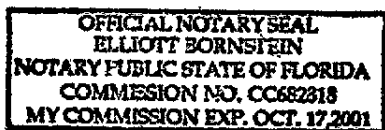


