Name of Corporations

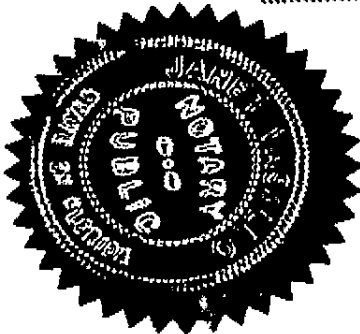
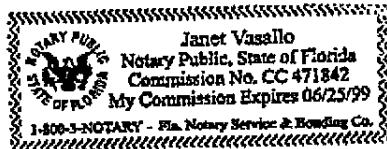
