To Whom It May Concern:

My purpose in writing this letter is to clarify the status of my retail business with you. I called your office several weeks ago after receiving a second Uniform Business Report. After explaining my situation to one of your caseworkers, he made a suggestion. He said the best thing for me to do was to write a detailed letter of explanation and to include all necessary documentation. He also said to request that all late fees be waived, since I originally filed my report and check on time.

The facts in this case are as follows:

- 1) Earlier this year I received the pre-printed Uniform Business Report. It listed me as the Registered Agent for the corporation and listed my address as a P.O. box (see Document #1). Since it came to me pre-printed, I figured all I needed to do was sign and date it and enclose my check for \$150.00, which I did. I deleted the name of my vice-president, who is no longer with the company, and mailed the UBR and the check on 04/21/00. The check was deposited by you on 04/27/00 (see Document #2) and cleared my bank on 05/05/00 (see Document #3).
- 2) In a letter dated 05/04/00 (see Document #4) you advised me that the check had been received but the report had not been filed because it needed to be corrected. You stated the reason was because the Registered Agent must have a street address and not a P.O. box. I corrected the form (see Document #5) and mailed it back to you on 05/16/00 by First Class mail. That being done, I assumed everything was fine as long as I did not hear from you again.
- 3) On 07/07/00 I received a second notice from you, stating that my corrected form had never been received. You stated this second notice must be filed by 09/13/00 and that an additional filing fee of \$400.00 was required. I cannot imagine why you never received the corrected form, since I mailed it in the pre-addressed envelope you provided and included my return address on a mailing label. Even if you did not receive it for some reason, it should still have been returned to me by the post office, and I have never received it. My accountant went online as recently as Monday, 08/21/00 to check on the status of my UBR and said it has still not been posted or updated. In fact, the second notice I received contains all the same information as the first one.

4) I am correcting this second notice just as I did the first one and will be mailing it on Thursday, 08/24/00. It is being sent as Certified Mail. This will let me know when it was signed for and by whom. That assures me there is no question that you received it.

I hope this letter clears up any confusion which might still exist. Please let me know as soon as possible if there is anything else I need to do. Once again, I am asking that all late fees be waived, since the report and check were originally filed on time. Thank you for your cooperation in this matter.
