ARTICLES OF INCORPORATION

OF

THE UNDERSIGNED Subscriber to these Articles of Incorporation, as a natural person, competent to contract, hereby forms a corporation for profit under the laws of the State of Florida.

ARTICLE I

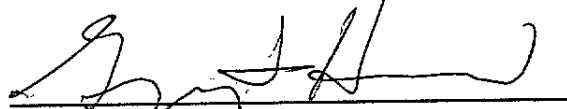
thereon unless all of the directors and all of the stockholders sign a written statement manifesting their intention that a certain amendment to these Articles of Incorporation be made.

The corporation shall indemnify all officers and directors, and former officers and directors, to the full extent permitted by law as the law now exists or may be amended hereafter.

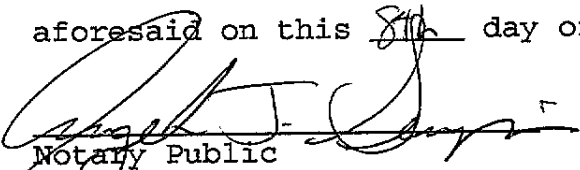

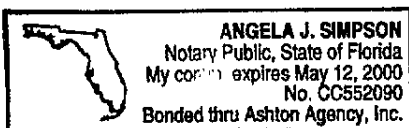

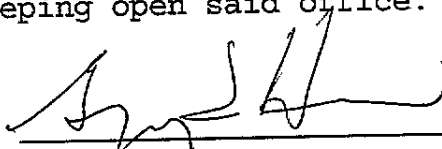
