The undersigned, acting as incorporator of a Florida Corporation under the Florida General Corporation Act, Chapter 607, Florida Statutes, adopts the following Articles of Incorporation for such corporation:

ARTICLE I. NAME

The name of the corporation is DAN JONES AND COMPANY, INC. and the principal address for the corporation is 8027 South Orange Avenue, Orlando, Florida 32809

ARTICLE II. DURATION

The corporation shall have perpetual existence unless sooner dissolved according to law.

ARTICLE III. PURPOSE
