#### ARTICLES OF INCORPORATION

### Med-Marketronics, Inc.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

Article 1. Name. The name of the Corporation is: Med-Marketronics, Inc. The principal office of the Corporation is 200 E. Robinson Street, Suite 500, Orlando, Florida 32801.
