**ARTICLES OF INCORPORATION OF

ARTICLE I - NAME

The name of the Professional Association shall be EZRA R. WITSMAN, P.A. whose mailing and physical address is 138 East Central Avenue, Howey-In-The-Hills, Florida 34737.

ARTICLE II - DURATION

The Professional Association shall exist perpetually.

ARTICLE III - PURPOSE

The purposes of this Professional Association shall be to own and operate a law office and conduct any other lawful business for which a professional association may be incorporated under the laws of the State of Florida and the United States of America.

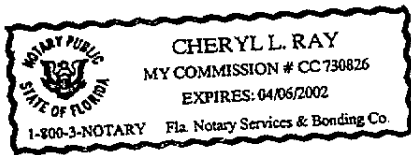

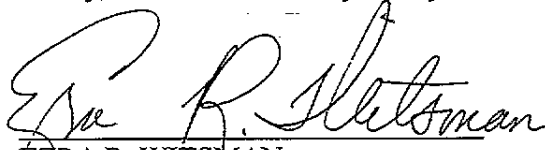
