ARTICLE I - NAME

The name of this Corporation is WDF FINANCIAL SERVICES, INC.


#### ARTICLE XII - AMENDMENT

ARTICLE XIII - EFFECTIVE DATE


The existence of this Corporation shall commence on the date of filing of these Articles of Incorporation with the Secretary of State.
