**ARTICLES OF DISSOLUTION OF
SPACE COAST GOLF PROMOTIONS, INC.**

Pursuant to the provisions of Section 607.1401 of the Florida Statutes, the undersigned Florida corporation hereby adopts the following Articles of Dissolution:

Article I - Name of Corporation

The name of the corporation is **Space Coast Golf Promotions, Inc.** (hereinafter referred to as the "Corporation").

Article II - Filing Date of Articles of Incorporation

The Articles of Incorporation of the Corporation were filed with the Secretary of State of the State of Florida on July 20, 1998.

Article III - Failure to Commence Business

The Corporation has not commenced business.

Article IV - Payment of Debts

No debt of the Corporation remains unpaid, and the remaining net assets of the corporation have been distributed to the shareholders.

Article V - Approval of Dissolution
