ARTICLES OF DISSOLUTION OF SPACE COAST GOLF PROMOTIONS, INC.

Pursuant to the provisions of Section 607.1401 of the Florida Statutes, the undersigned Florida corporation hereby adopts the following Articles of Dissolution:

Article I - Name of Corporation

The name of the corporation is **Space Coast Golf Promotions**, **Inc.** (hereinafter referred to as the "Corporation").

Article II - Filing Date of Articles of Incorporation -

The Articles of Incorporation of the Corporation were filed with the Softhe State of Florida on July 20, 1998.
