ARTICLE I

The name of this Corporation shall be as follows: JORGE MEJIA, M.D., P.A. The principal office and mailing address of the corporation shall be 13349 S.W. 151st Terrace, Miami, Florida 33186.

ARTICLE II

The commencement of existence of this Corporation shall be July 22nd, 1998.

ARTICLE III

EFFECTIVE DATE

07-22-98

The general purpose for which this Corporation is initially organized shall be the transaction of all lawful business for which corporations may be incorporated under the laws of the State of Florida, as well as, specifically, the practice of medicine.

ARTICLE IV

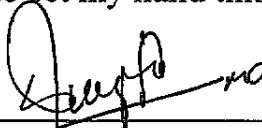

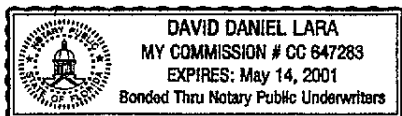
