Pursuant to provisions of the Florida General Corporation Act, the
Undersigned Corporation adopts the following Articles of Amendment to the
Articles of Incorporation.

1. The name of the corporation currently is F.C. Advisory Services,
Inc.
2. The following amendment of the Articles of Incorporation was
adopted by the shareholders of the corporation on the 1st day of
January, 2002, in the manner prescribed by the Florida General
Corporation Act.

Effective immediately, the corporation shall change its name from F.C.
Advisory Services, Inc. to F.C.B. Advisory Services, Inc.

The principal purpose of this corporation will be the financial advising of
business and personal clients. The Corporation may engage in any or all
lawful business permitted to corporations under the laws of the State of
